

Hemsted has served many important roles throughout her tenure as a CattleWoman. She was the President of the California CattleWomen, an ANCW Region Director, Chair of the National Beef Cook-off committee, Co-chair of the ANCW Education Committee and served on numerous regional committees. She was a champion for a large ANCW re-structure project as a part of the Focus Advisory Team and created "196 Ideas to Recruit New Members." With 24 years of ANCW membership, she's attended nine summer conferences, 12 annual conventions and today is still active in CattleWomen, serving as the Budget Chair and local CattleWoman director in California.

Her impact on Beef Education is significant. She has volunteered many hours in elementary classrooms delivering programs like "Music, Literature, Art and COWS!" program and she's encouraged hundreds of women to become certified in special ANCW Education projects. Her passion for education carried beyond her work with CattleWomen, proven by her service as the first national chairman of Ag in the Classroom. The strong relationships Hemsted has built with CattleWomen across the country are remarkable. Barbara Jackson, ANCW President said "Joan has a tremendous talent for engaging members. Whomever she works with-she does it with style and grace AND she gets the job done! Her co-workers



(committee) are always happy to have worked with Joan."

Jean Barton fellow ANCW member and California CattleWoman agreed, stating "Joan's personality and hugs have created many friends throughout the United States in the beef industry."

Edith Irene Kearns was born July 13, 1929, to Owen and Jeannie (Sutton) Kearns and passed away December 6, 2013, at the Aberdeen Health and Rehabilitation Center. Funeral services were held December 14 in Gettysburg. She grew up in rural western Potter County, attended rural grade school and graduated from Gettysburg High School in 1947. She married Louie Bartels on Nov. 27, 1949. Four children were born to this union. They lived 62 years on their farm west of Gettysburg; the last two years, they have resided in Aberdeen.



Edith will long be remembered as a loving wife, mother, grandmother and great-grandmother. She was deeply involved with 4-H. Her family and friends laugh that she taught half of Potter County how to sew – not just the daughters in 4-H, but their mothers too. A superb cook, Edith cooked meals for her family and farm-help yearlong and for as many as 15-20 at harvest time, in addition to the many banquets for numerous groups especially FFA and FHA (FCCLA) Awards. Being an Extension Club member fueled her love for teaching youth and being active in her community. She was honored to receive the SD Eminent Homemaker Award in 1999. Edith was a founding member of the Medicine Rock Cowbelles, served on the South Dakota Beef Council; the Cowbelles later became the American National CattleWomen. She enjoyed her many roles as a part of the State and National Beef-Cook-Off competitions, serving at all levels, including Chairman when South Dakota hosted the Cook-Off in 1981. She helped develop and install Ag in the Classroom throughout our schools and traveled at the state and national level promoting agriculture and beef industry. In honor of her work, she was inducted into the South Dakota Hall of Fame in 2004. She was a 50+ year member of Eastern Star, active in Job's Daughters, United Methodist Church and American Legion Auxiliary. In their retirement years, Edith and Louie enjoyed winters in Sun City West, AZ. There, Edith began extensive research of family genealogy providing numerous notebooks and family photos to Bartels, Kearns and Sutton families. She also enjoyed being a member of the International Ikebana Society, exploring the art of Japanese flower arranging.

Services held for Ken Halligan

(8-2-1921 to 1-29-2014)

Kenneth William Halligan was born August 2, 1921, to Frank and Ethel (Rousch) Halligan at Cedar Butte, SD, and passed away January 29, 2014, at his home in Pierre.

In 1931, they moved their family to Parmelee, SD. Ken attended school at Running Bird for the first four years and transferred to Parmelee School after the move, remaining there through the 11th grade. His senior year was spent at Curtis, NE attending the Nebraska School of Agriculture.

On August 15, 1942, Ken entered the Army to become a Signal Corp lineman with the 101st Signal Battalion. He was attached to the 7th Infantry Division as "Special Forces". Ken received several awards and citations, including the Purple Heart, and had achieved the rank of 1st Sgt. by the time he was honorably discharged. After World War II, Ken worked for three years as a lineman for Bell Telephone Co. in Rapid City and Valentine, NE. During this time he met Ruth Louise Verch. They married on October 5, 1947, and Ken returned to ranching at Parmelee. Then, in 1954, they moved west of Ft. Pierre, SD where Ken was a partner in the Rankin Ranch operation for 10 years. In 1964, Ken and Ruth purchased a ranch on the White River south of Draper and moved there with their five children. They spent many happy years running cattle and irrigating crops on the river bottoms until 1995 when they moved to Pierre. Ruth had been fighting cancer and passed away in March of 1996.

Ken worked as an order buyer for Gottch Feed Corporation during his 'retirement' and married Florence Williams on November 2, 1997, in Eagle Butte, SD. They made their home in Pierre. Ken was very involved in every community in which he resided. He served on the school board for Tomahawk District in Stanley County for ten years and was a Jones County Commissioner for ten years. He was proud to serve as a Charter Member for the SD Cowboy Hall of Fame, where he served on the Board of Directors, and was the last living Charter Member at the time of his death. He and Ruth were both inducted into the Hall of Fame. Ruth was inducted into Teaching and Cultural Affairs in 1990 and Ken into Agriculture in 1996.

The West River/Lyman-Jones Rural Water Board was a special interest of Ken's for 34 years. He was a lifetime member and served twice as commander of American Legion Otterman Post #94, was a lifetime member of the Veterans of Foreign Wars and also the Disabled American Veterans. In 1999, Ken and the entire Halligan Family were honored to be inducted into the Casey Tibbs Foundation. Ken worked tirelessly for the South Dakota Stockgrowers Assn. and served as Vice President beginning in 1986 and



President in 1988. He also served on the S.D. Brand Committee and was appointed to the Brand Board in 1998 where he served for five years. He was a lifetime member of the Aberdeen Angus Association.

Ken's faith was an important part of his life. He was a member of the American Sunday School Union in Parmelee until he joined the Methodist Church in Valentine, NE. He was a Trustee and on the Pastor Parish Board for the Little Brown Church at Hayes, SD and the Draper Methodist Church. He was a member of the Pierre Methodist Church at the time of his death.

Grateful for having shared his life are his five children: Frank (Shirley) of Midland; Bill (Virginia) of Bushnell, NE; Linda (Ray) Gilbert of Buffalo; Jim (Barb) of Pierre and Laura (Tim) Olson of Buffalo; 10 grandchildren; nine great-grandchildren; a sister, Irene Hutchison and numerous nieces and nephews.

Ken was preceded in death by his wife, Ruth, his parents, brothers: Eugene, Delbert, Bernard and Daryl and wife, Florence Williams Halligan.

It is the experiences like these, the ones that help benefit the lives of consumers, which make the Beef Ambassador position so rewarding. I also had the opportunity to offer Governor Dennis Daugaard a sample. My second promotional event occurred in Sioux Falls at the Women's Expo for Her Event. With football season in full swing, the ladies loved the No Noodle Lasagna Beef Dip samples that I helped hand out along with brochures promoting lean beef in a healthy diet along with other recipes. In November, the South Dakota Beef Industry Council, along with the American Heart Association, teamed up to host the National Eating Healthy Cooking demo at Strawbale Winery in Renner. It was a full house as Chef Amy Warren prepared Smoky Round Roast with Garlic Kale as well as Pesto Steak and Arugula Pizza.  ANCW meeting in Nashville**

“Follow me to Tennessee” was this year’s theme to the 116th Cattle Industry Annual Convention and National Cattlemen’s Beef Association Trade Show, which involved ANCW, NCBA, CBB, CattleFax and National Cattlemen’s Foundation. Shirley Thompson and Kodi Blotsky represented the South Dakota CattleWomen.

Focus sessions were on Mom’s, Millennial and More (M3) training, beef promotion and youth development. It was stressed during M3 training that M3 programs are check-off programs, not ANCW programs, because it is funded with check-off money. ANCW are managers of the programs. One new message about beef we need to focus on as a USDA recommendation is that **“Beef is Nutritious”** and not that it is healthy. We learned one way to promote beef is by blogging. Research shows 80 percent of the people log into social media.

The focus area in youth development is working groups for National Beef Ambassador Program, Consumer Youth Education and Curriculum, Collegiate CattleWomen and the new Junior CattleWomen.

Specific committee meetings were held, as well as a President’s Council and executive committee, board of directors, general membership and 2014 executive meetings. Two of the main topics were ANCW’s proposed restructure flow and a number of by-law changes that needed to be updated.

Kodi said, “I came away overwhelmed but energized at the same time. I realize more now that we do have a strong community of support people that can help us here in South Dakota with project ideas and other issues we come across. I will talk about all of this at the upcoming quarterly meeting March 10 in Pierre.”
