SDCW Annual Meeting held December 3 in Pierre



The SDCW quarterly meeting was held Wednesday, Dec. 3, at 10:00 a.m. at the BIC conference room in Pierre. President Kodi Blotsky called the meeting to order. The SDCW creed and flag salute were done in unison by the nine members present. Carol Sides moved to approve the agenda and Lisa seconded the motion. Motion carried. Mary H. moved and Carol S. seconded to dispense with reading the minutes and approve them as printed in the newsletter. Kodi did the treasurer's report for Erin and stated that basically nothing much has changed since the last report. The SDCW budget for BIC is \$28,000.

REPORTS:

Newsletter: February 1 is the next deadline and the directory is scheduled to be put in. Information and photos should be gotten to Mary Jessen or the Highmore Herald.

Beef Certificates: Lindy gave the Beef Certificate report. She has put statewide ads in the papers and mailed letters to past customers. She asked about radio ads, but no decision was made. A suggestion was made to put an email address on the certificates when she orders them. She will be ordering 8,000 soon for \$2,400. A total of \$105,295 in beef certificates were sold from December, 2013 to December, 2014 and had redemptions of \$50,000. Beef certificates are used for blood drives also. It was suggested that Kodi put the information on Facebook. At present, Huron and Sioux Falls do not have an outlet to sell the certificates.

Membership: Katrin and Becky reported on membership. At present, there are 70 associate members and 250 state members. It was also noted that ANCW is in need of more members.

BIC Council: Kodi reported that there is a proposal out to implement a second check-off. Members need to be aware of it and discuss and talk about it and the need for it or not.

Website and Facebook: Ruth F. is working on it and had a recipe for lasagna soup, which had many hits on Facebook.

OLD BUSINESS:

Annual Meeting: Review that we had good speakers on Friday, Katie Pinkie and Ann Price. Katie will be asked to present at the region meeting.

Expo for Her, Sioux Falls: Kodi attended along with Laurie Johnson, Auxiliary President. Patti Buck, ANCW President, was present. Many women attended.

Final Project Report Books: It was suggested a booklet should be made of activities and projects the clubs have done. A new project report form for BIC has to be filled out before funding can be received. Clubs need to get their reports in.

Christmas Tree: The SDCW did not have one

at the capitol this year.

NEW BUSINESS:

Parliamentarian: Are there any volunteers?

ANCW Convention, San Antonio, TX: February 3-7. Anyone interested in attending? Kodi will not be able to go. Part of the expenses are paid by SDCW (room and flight). ANCW has a new executive director, Kathryn Carruth. ANCW is selling a beef necklace - anyone interested can get the order form from Kodi. Kodi will write-up the State Project Report for ANCW by December 15 for the ANCW annual meeting booklet.

Beef Check-off vs. Generic Check-off: Flyer sent around. It needs to be studied. This was a note from Karla.

Beef Day at the Capitol: No date set. Tracy Walsh is in charge. A letter was passed around about Tribal Relations. This is too political for the SDCW and not in line with our "Points of Policy". Declined.

Cookbooks: Ruth F. and Becky L. are working this and are in need of recipes. Morris in Nebraska will do the printing. A goal of 250 recipes is set and want to have them to Morris before January 15 to receive a discount. This book will be similar to the 60th anniversary cookbook.

PROJECTS GONE OVER:

Beef Basket: Where to hold it?

Beef Ambassador Contest: Ruth F. chairing and needs help. Where to hold it?

Beef up your Bike: \$8,000 Budget. This will be 75th anniversary at Sturgis Rally.

Promotion: Suggestions for bumper stickers, jersey, t-shirts, cutting boards, toothpick holders.

Sponsorships: SDCW will do 4-H awards for illustrated talks and demonstrations on beef with a \$25.00 cash award from the SDCW account. Mary H. moved and Kay A. seconded to do this.

Mary H. says the investment account has approximately \$140,000 in it. Mary H. also suggested that associate dues should be raised. No decision made. Discussion was held about returning the \$5.00 rebate, if requested, for members selling associate memberships. This was tabled until next meeting.

The Beef Ambassador contest is usually held in July in Huron. It was suggested that it could be held during Beef Bowl at SDSU and the BIC Annual Meeting in September.

Region III and VII meeting will be May 14-16 at Joy's Ranch near Watertown. SDCW is working with Cattleman's Auxiliary President, Laurie Johnson.

It was suggested the next meeting be held after Beef Day at the Capitol.

Lindy moved and Lisa seconded to adjourn the meeting at noon.

Marjorie Ellen Larson (Marge) was born February 7, 1929, in Belle Fourche to Chris William and Amy Kent Larson. Marge grew up on the family ranch near Fruitdale, where she attended grade school at the Hillside Country School. She was a 1947 graduate of Belle Fourche High School and attended SDSU, earning a degree in Home Economics. She was a home economist in eastern South Dakota, before moving to Albion, MT to be a rural school teacher. She also taught in Spearfish, Rapid City Central, Lemmon, and Bison and was a home economist for the Safeway Corp. and Black Hills Power and Light. In 1961 she was united in marriage to Richard (Dick) Reder at the United Methodist Church in Belle Fourche. To this union three children were born: LeAnn, Wanda, and Scott. Following their marriage, Dick and Marge lived on their ranch near Prairie City in Perkins County. In 1970 they moved to Nisland where they ranched while summering livestock near Prairie City and north of Belle Fourche. Marge battled progressive Dementia that became more evident after Dick's death in 1997 and was furthered when she was badly injured with broken bones from an angry bull attack in 2003. She was a member of Carcass Cut-Ups CattleWomen.

Marge enjoyed the ranch life as an active partner with her husband. She enjoyed working with livestock and running the swather during the hay season. In 1989 she was honored as the SD Cattlewoman of the Year. Marge was also very active in the community. She served on the Northwest Regional Library Board, state/county Farm Bureaus, and on the Butte County Conservation Board. She was a representative to the Western Resource Conservation and Development Association, a multi-state soil conservation alliance, where she received the President's Award for her contributions in 2000. Marge was a faithful member of the Nisland Independent Community Church where she was always active with music and the ladies aid ministries. Marge enjoyed piano, dancing, public speaking, writing poems, sketching depictions of ranch life,

participating in the extension club, and playing in the Cowboy Band. She served on the 4-H Extension Board and provided 4-H leadership at the county and state levels. Because of her lifetime commitment to 4-H, a memorial will be established in her honor to recognize overall achievement in SD.

She is survived by her daughter, Wanda Reder of Chicago, IL; her son, Scott (Angela) Reder of Fruitdale and their three children, Whitley, Reece and Raina. She is also survived by her niece, Carol (Chuck) Wood of Gillette, WY.

Beef Taco Wrap Salad

Teen Contestant in the 2014 SD Beef Cook-off

- 1.5 lbs. Lean Ground Beef
- 15.5 oz. Mild Chunky Salsa
- 15.5 oz. Chili Beans, drained
- 2 Tbsp. Worcestershire Sauce
- 4 tsp. Onion Powder
- 4 tsp. Chili Powder
- 1/2 tsp. Garlic Powder
- 1/2 tsp. Pepper
- 6 8-inch 100% Whole Wheat Tortillas
- 2 8-oz. Bags Shredded Lettuce
- 6 Plum Tomatoes, chopped
- 8-oz. Bag Light Colby Jack Cheese
- 1.5 Cups Crushed Multi-grain Tortilla Chips
- Light Western Dressing to drizzle on top

In nonstick skillet, cook beef over medium heat until no longer pink; drain. Stir in salsa, beans, Worcestershire sauce and spices. Bring to a boil; reduce heat and simmer, uncovered for five minutes. Lay one tortilla wrap on each plate and spoon meat mixture evenly on top. Layer with lettuce, tomato, cheese and crushed chips. Drizzle Light Western Dressing on top of each salad wrap. Garnish with fresh kale and decorative raw vegetables.
