Julie moved to dispense with reading of the secretary's minutes and Carolyn seconded the motion, with all voting in favor.

Kodi gave the treasurer's report for Erin. Ruth moved and Julie seconded that the goal for the coming year is to gain 25 new members, before the 2015 convention. Motion passed.

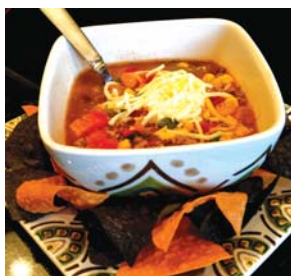

Terrifying Taco Soup

- 1 lb. lean ground beef
- 1 package low sodium taco seasoning
- 1 can low sodium black beans
- 1 can low sodium pinto beans
- 1 can mexi-corn
- 1 can Rotel tomatoes
- 1 can low sodium diced tomatoes
- 1 package Mrs. Dash Ranch Seasoning
- Fresh Peppers, onion, etc.
- 1 carton low sodium beef broth
- Mrs. Dash Fiesta Lime Seasoning



Brown ground beef, drain and rinse any excess grease. Add taco seasoning. Prep any fresh ingredients you plan to use (red peppers, onion, jalapeños, etc.). Combine beans, corn, Rotel, tomatoes, peppers, onion, beef broth and ranch seasoning in crockpot. Add ground beef once fully cooked. Season with Mrs. Dash Fiesta Lime, if desired. Set crockpot on low for 4-6 hours. Garnish with your favorite taco toppings and enjoy!

USDA Developing a New Beef Order

By now, you may have heard that Secretary of Agriculture, Tom Vilsack announced on September 30 that he was going to implement a new beef check-off program by January, 2016. The new order would be **in addition** to the existing Beef Check-off that we know today and would operate concurrently with the Beef Check-off Program authorized under the authority of the 1985 Act. Only through a Congressional action can the current \$1.00 per-head-of-cattle per producer, the dollar that is collected and sent to the South Dakota Beef Industry Council housed in Pierre, change the amount that would be collected. Vilsack's mandate would be formed via the Commodity Promotion, Research and Information Act of 1996 and be overseen by the Secretary of Agriculture.

It is a complex issue and it will directly affect all of us in the beef industry.

Interested individuals and organizations are invited to provide their views concerning provisions that would be included in the new order. A referendum on an order established under the 1996 Act would be conducted within three years after assessments begin to determine whether beef producers favor the program and if it should continue. A second referendum would be held within seven years of the start of the program.

Interested parties have until Dec.10, 2014, to submit comments. I hope we, as South Dakota CattleWomen, can have a discussion at our next quarterly on this and encourage all individuals to also submit written comments to USDA on their proposed promotion, research and information program.

Details of the notice of inquiry will appear in the Nov. 10, 2014, Federal Register. Comments may

be submitted online at www.regulations.gov or sent to Beef Promotion, Research, and Information Order; Research and Promotion Division, Room 2096-S; Livestock, Poultry and Seed Program; AMS, USDA, STOP 0249; 1400 Independence Avenue, S.W.; Washington, D.C. 20250-0249; telephone number (202) 720-5705.

Suggested comments may be: Who should be assessed? What should be the board structure? Who has decision-making authority? How should the assessment rate be determined? and How should assessments be collected?

Until we see the actual proposal, which is expected to be determined by the end of 2014, it is hard to make a factual decision. I personally am concerned anytime Government replaces Grassroot leadership and decision-making.

Please take your role as SDCW seriously and submit comments to the above regulations site.

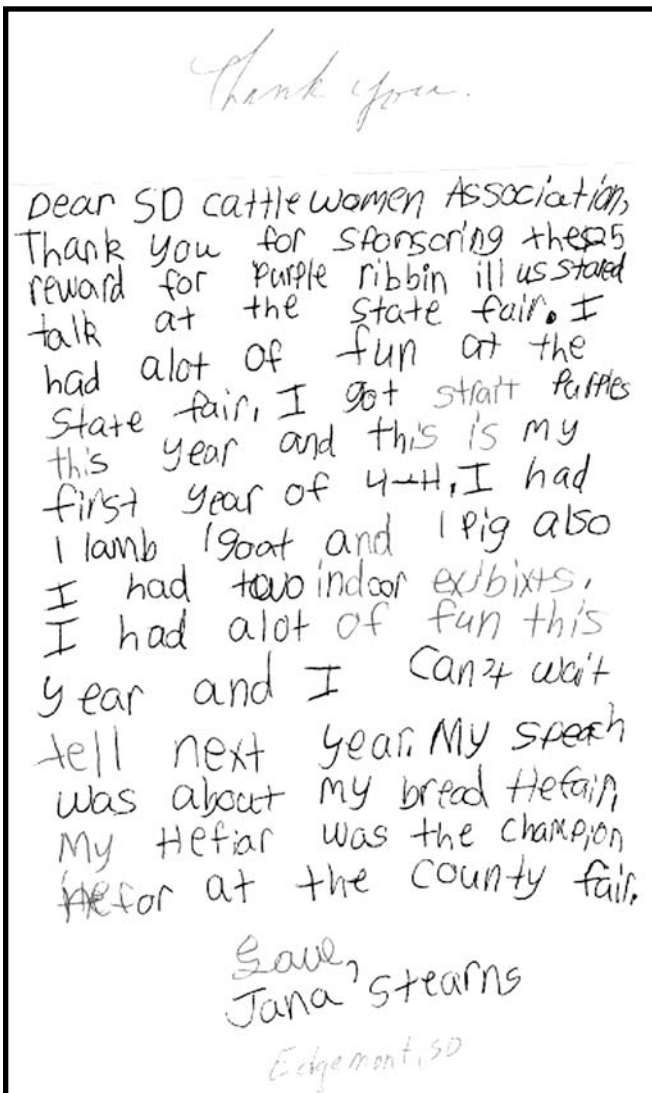

2014 BEEF COOK-OFF RECIPES

Barbecue Western Beef Rolls

Tammie DeWald of Milbank, First Place (adult)

- 6 Beef Cube Steak (2.25 lbs.)
- Steak Seasoning to taste
- Texas-style Organic Barbecue Sauce, 18-oz. bottle
- 8-oz. Pkg. Shredded Light Cheddar Cheese
- 11-oz. Can Mexi-corn, drained
- 3/4 cup of Pkg. Frozen Diced Onions, unthawed
- 2.25-oz. Can Sliced Ripe Olives, drained
- 12 Slices of Maple Low Sodium Bacon

Sprinkle steak seasoning on both sides of steak and brush with barbecue sauce. Sprinkle cheese, mexicorn, onions and olives on steak evenly. Roll-up jelly roll fashion. Wrap two pieces of bacon around each steak roll. Broil 3 to 4 inches from heat 20-25 minutes. Turn rolls about every 5 minutes and brush with remaining sauce. Sprinkle with more cheese and serve with barbecue sauce. Garnish with fresh kale and decorative raw vegetables.

South Dakota Beef Sesame

Carter Dreyer of Warner, First Place (youth)

- 1.5 lbs. Lean Ground Round, browned and drained
- 14-oz. Raw Cabbage Coleslaw Mix
- 3 Tbsp. Sesame Oil
- 1/2 tsp. Ginger
- 1/2 tsp. Cayenne Pepper
- 3 Tbsp. Soy Sauce
- 1/2 cup Sliced Almonds
- Sliced Tomatoes for garnish

Chinese Hot Mustard/Sweat and Sour Sauce on side
Pita Pocket Bread

Add cabbage and sesame oil to browned beef. Stir frequently over medium high heat until cabbage wilts. Add dry seasonings and soy sauce. Cook until soy sauce reduces. Spoon mixture into pita bread. Garnish with tomatoes and serve with Chinese mustard or sweet and sour sauce on the side.
